
National Museum, New Delhi invites Sealed quotations for checking/Repairing/Service of Sony LCD Data Projector Model VPL-FX 500 L (WUXGH) 7000 ANSI luminous and SITC of lamps, connectors VGA and HDMI with all accessories. Sealed quotation may be submitted in sealed envelopes super scribed as "SITC and service of Video Projection system" addressed to Administrative Officer, National Museum, Janpath, New Delhi-110011 so as to reach the undersigned by 02:00 p.m. on or before 14th October 2016. Quotation will be opened on the same day i. e. 14th October 2016 at 2:30 p.m. by the Local Purchase Committee of the National Museum in the presence of the tenderers or their representatives who may like to be present. The specifications and quantities of above mentioned equipments are on "ANNEXURE-A" of this letter.

While furnishing the quotations, following points should be carefully noted:-

1. The invitation is open to all well-established/Registered suppliers/authorized dealers/manufacturers genuine suppliers who are having PAN/TAN/VAT/TIN registration in their name.
2. "Quotation" should be written in block letters on the top of the envelope. The last date submission of the quotation and office reference no. may also be mentioned on the envelope.
3. Any other charges, if any, such as packing and forwarding, delivery charges, sales tax etc. should be mentioned clearly and separately. In case nothing is mentioned in this regard then it will be presumed that the rates quoted by the firm are inclusive of all such charges/taxes and no claim otherwise will be entertained in this regard later on.
4. Quotations received after the prescribed date and time will not be considered.
5. Articles for which quotations are furnished should be available for inspection to a representative of the Museum if required by this office.
6. Please mention if the materials, rates for which have been quoted in quotation is readily available with you and whether you will be able to supply the items at a short notice.
7. If the representatives wish, they can be present during the opening of quotations.

9. Please submit EMD (Earnest Money Deposit) for an amount of Rs. 2,000/- (Rupees two thousand only) in the form of Demand Draft in favour of D.D.O., National Museum, New Delhi, Quotations without EMD shall be liable for rejection.
10. The earnest money deposited by the awardees will be converted in to security deposit.
11. The supplier will also be responsible for delivery of the goods in good condition in the office of National Museum at his own risk and cost.
12. It should be mentioned whether the products for which rates are quoted are from authorized dealer/distributer/manufacturer or not.
13. In case the rates are found to be more than prevailing market rates at any stage, the payment will be restricted to that rate/price and the firm/agency will not have any right to challenge this. No representation will be entertained in this regard.
14. In case the supplier is not able to supply goods for which supply order has been placed within the stipulated period of time, the supply order shall be cancelled and earnest money deposit of Rs. 2,000/- (Rupees two thousand only) would be forfeited.
15. Dispute, if any, arising between the successful firm/agency and the National Museum shall be resolved amicably, failing which it shall be referred to an Arbitrator, mutually acceptable to both parties, appointed by the Director General, National Museum as per the Arbitration and conciliation Act 1996. Alternatively, this shall be subjected to the exclusive jurisdiction of court at Delhi.
16. Director General, National Museum reserves the right to accept or reject all the tenders in part/full or divide the work among two or more parties without assigning any reason whatsoever and in such case bidder/intending bidders, shall not have any claim on office of Director General, National Museum, New Delhi.
