1. 'QUOTATION for “Nizam Jewellery miscellaneous materials” should be written in block letters on the top of the Envelope. Last date of submission of the quotation and office reference no. may also be mentioned, on the envelope
2. PLEASE SUBMIT EMD(EARNEST MONEY DEPOSIT)FOR AN AMOUNT OF **RS.5000/- (RUPEES FIVE THOUSAND ONLY)**IN THE FORM OF DEMAND DRAFT IN FAVOUR OF D.D.O, NATIONAL MUSEUM, NEW DELHI, QUOTATIONS WITHOUT EMD SHALL BE LIABLE FOR REJECTION.
3. In case the vendors is not able to repaired the showcase for which work order has been placed within the stipulated time is 15 days from issue of work order, the supply order shall be cancelled and earnest money deposit by vendor of Rs. **5,000/-** shall be **forfeited**.
4. Tenderers may please quote their unconditional rates strictly as per schedule of goods enclosed.
