Eligibility Criteria and Terms and Conditions


01The invitation is open to all established genuine venders who are having PAN/TAN/GST/TIN registration in their name

2. 'QUOTATION for "Repairing of Photocopier Machines" should be written in block letters on the top of the Envelope. Last date of submission of the quotation and office reference no. may also be mentioned, on the envelope
3. PLEASE SUBMIT EMD(EARNEST MONEY DEPOSIT)FOR AN AMOUNT OF **RS.5000/- (RUPEES FIVE THOUSAND ONLY)**IN THE FORM OF DEMAND DRAFT IN FAVOUR OF D.D.O, NATIONAL MUSEUM, NEW DELHI, QUOTATIONS WITHOUT EMD SHALL BE LIABLE FOR REJECTION.
4. In case the vendors is not able to repaired the machines for which work order has been placed within the stipulated time is 15 days from issue of work order, the supply order shall be cancelled and earnest money deposit by vendor of Rs. **5000/-** shall be **forfeited**.
5. Tenderers may please quote their unconditional rates strictly as per schedule of goods enclosed.
6. The National Museum reserve the right to reject any or all the tender in full or part without assigning any reason therefore and without giving any compensation. The decision of the D.G. National Museum in this regard shall be final and binding on all.

7. It should be clearly mentioned whether the rates are inclusive of GST, taxes, cartage etc. or otherwise. In case nothing is mentioned in this regard then it will be presumed that the rates quoted by the firm are inclusive of GST. Cartage etc. and no fresh claim in this regard will be entertained.
