

ELIGIBILITY CRITERIA AND TERMS AND CONDITIONS


1. The invitation is open to all firms who are in the business of Scrap.
2. ‘QUOTATION’ should be written in block letters on the top of the envelope. Last date of submission of the quotation and office reference no may also be mentioned on the envelope.
3. The firm who is interested to participate in this tender may visit the National Museum to check and see the unused glasses laying in the National Museum and evaluate accordingly.
4. The cost of unused glasses may be indicated in the quotation clearly.
5. PLEASE SUBMIT EMD (EARNEST MONEY DEPOSIT) FOR AN AMOUNT OF Rs.5000.00 (RUPEES FIVE THOSUAND ONLY) IN THE FORM OF DEMAND DRAFT IN FAVOUR OF



D.D.O., NATIONAL MUSEUM, NEW DELHI. QUOTATIONS WITHOUT EMD SHALL BE LIABLE FOR REJECTION.

6. Dispute, if any, arising between the successful firm/agency and the National Museum shall be resolved amicably, failing which it shall be referred to an Arbitrator, mutually acceptable to both parties, appointed by the Director General/Administrator, National Museum as per the Arbitration and Conciliation Act 1996. Alternatively, this shall be subjected to the exclusive jurisdiction of court at Delhi.

Director General/Administrator, National Museum reserve the right to accept or reject all the tenders in part or full or divide the work among two or more parties without assigning any reason whatsoever and in such cases bidder/intending bidders, shall not have any claim on office of Director General, National Museum, New Delhi.
